



IMPORTANT: READ THIS AGREEMENT CAREFULLY BEFORE DOWNLOADING OR USING eaTeamWorks. BY DOWNLOADING OR USING eaTeamWorks, YOU AGREE TO BE BOUND BY THE TERMS AND CONDITIONS OF THIS AGREEMENT. IF YOU DO NOT AGREE TO THE TERMS OF THIS AGREEMENT, DO NOT DOWNLOAD OR USE eaTeamWorks.

DFFINITIONS

- 1. In this Licence Agreement, unless the contrary intention appears:
 - 1.1. "Product Suite" means the eaTeamWorks suite of software products offered by Ability Engineering Ltd. which includes free and paid software features and online and electronic documentation.
 - 1.2. "Licensee" means the individual or entity that downloads or uses the Product Suite.
 - 1.3. "Free Features" means the features of the Product Suite that are available to use perpetually without requiring any payment.
 - 1.4. "Individual Product" means a software product, consisting of a subset of the Product Suite features that are grouped together and can be purchased separately. Individual Products are eaDocX, ea Revision Manager (extension for eaDocX), eaSheets, Model Expert and Portfolio Manager
 - 1.5. "Annual License" means the license to use an Individual Product or the entire Product Suite for a period of one year.
 - 1.6. "Single User licence" means a licence for installation on a single computer (physical or virtual).
 - 1.7. "Group licence" means a licence to be shared between a team of users, up to the specified total number of users.
 - 1.8. "Support Services" means email-based support provided by Ability Engineering Ltd. including advice on usage of the software product, investigation of bugs, fixes, download of new versions, and general product support.
 - 1.9. "Ability Engineering Ltd." is the company number 3639900, Registered address The New Inn Business Centre, 527 Moseley Road, Balsall Heath, Birmingham B12 9BU.

GRANT OF LICENSE

- 2. This agreement is between you as Licensee and Ability Engineering Ltd. for the use of the Product Suite.
- 3. Subject to the terms and conditions of this Agreement, Ability Engineering Ltd. grants Licensee a non-exclusive, non-transferable, limited license to use the Product Suite, including the Free Features and any Individual Product that is purchased, solely for Licensee's own use.
- 4. The copyright in the Software Product Suite and its documentation is owned by Ability Engineering Ltd.

TRIAL PERIOD

- 5. Licensee may use any Individual Product within the Product Suite for a free trial period of 30 days. At the end of the trial period, Licensee must purchase an Annual License to continue using the Individual Product.
- 6. The free trial period for each Individual Product is independent of all other Individual Products. To take a free trial of ea Revision Manager, a user must have a valid eaDocX licence, or be taking a trial of eaDocX.





ANNUAL LICENSE

- 7. Licensee may purchase an Annual License for any Individual Product or for the entire Product Suite. The Annual License fee is based on the number of users and the duration of the license.
- 8. Upon purchase of a Single User licence for the Product Suite or any Individual Product, you are granted one of the following rights:
 - 8.1. The right to install and use one copy of the software product on a single computer; or
 - 8.2. To store or install a copy of the software product on a storage device, such as a network server, used only to install or run the software product for a single user.
- 9. Upon purchase of a Group licence for the Product Suite or any Individual Product, you are granted one of the following rights:
 - 9.1. The right to install and use the software product on the number of computers according to the licence size purchased; or
 - 9.2. To store or install a copy of the software product on a storage device, such as a network server, used only to install or run the software product for the number of users, according to the licence size purchased.
- 10. You are also granted the following rights:
 - 10.1. To use the product until the licence expiry date.
 - 10.2. To make copies of the software product for backup and archival purposes only.
 - 10.3. To receive Support Services during the validity period of the licence.
 - 10.4. To move the product from one computer to another, provided it is it still to be used by the original user.
 - 10.5. For the duration of the validity period, to submit requests for new function, and report bugs via https://www.eateamworks.com/ and to receive Support Services.
- 11. By accepting these licence terms, you also give permission for your computer to send, at a time interval to be determined by Ability Engineering Ltd, some details of your computer to Ability Engineering for the purposes of fraud detection. These details will be:
 - 11.1. The MAC (Media Access Control) address of the network card of your computer
 - 11.2. The IP address of your computer
 - 11.3. The licence key which you are using on your computer.
 - 11.4. The software version which you are running.
 - 11.5. Usage information, including but not limited to the individual products and features of the software used by the customer.
- 12. Ability Engineering Ltd. will use this information to:
 - 12.1. determine whether the licence is being used in accordance with the terms of this agreement,
 - 12.2. inform you of any software updates which you may wish to install
 - 12.3. help Ability Engineering improve the Product Suite
 - 12.4. provide technical support.
 - 12.5. and for no other purpose.
- 13. Usage information is considered confidential and will not be shared with any third party except as required by law.
- 14. By using the Product Suite, Licensee consents to the collection and use of usage information by Ability Engineering.
- 15. If Ability Engineering suspects that the licence is not being used in accordance with this agreement, then a warning will be issued which will be shown to the user.





- 16. If Ability Engineering determines that the licence key is not being used in accordance with this agreement, then Ability Engineering Ltd. may disable the licence key.
- 17. For the avoidance of doubt, if you wish to increase the number of users entitled to use the software product, you must purchase additional licences.

Purchase of Additional Support Services

18. Licences for the Product Suite and Individual Products have a fixed expiry date. To extend use of the software after licence expiry, and to receive product support services, new licence(s) must be bought.

Additional limitations

- 19. You agree not to:
 - 19.1. Sell, lease, sub-license, loan or distribute the software product.
 - 19.2. Translate, adapt, vary, modify, decompile, disassemble, reverse engineer, create derivative works of, modify, or otherwise interfere with the software product.
 - 19.3. Reproduce or distribute licence key codes.

Assignment

20. You may assign your rights under this agreement to another person within the same organisation, provided that that person first confirms via email to Ability Engineering Ltd. at https://www.eateamworks.com/contact-us/ that he or she agrees to the terms of this agreement.

RESTRICTIONS

- 21. Licensee may not use the Product Suite to violate any laws or regulations.
- 22. Licensee may not remove or alter any copyright or other proprietary notices in the Product Suite.

SUPPORT AND MAINTENANCE

- 23. Ability Engineering Ltd. will provide support and maintenance for the Product Suite during the term of the Annual License.
- 24. Ability Engineering Ltd. may provide updates and upgrades to the Product Suite during the term of the Annual License.

TFRMINATION

- 25. Licensee may terminate this Agreement by ceasing to use the Product Suite.
 - 25.1. Ability Engineering Ltd may terminate this Agreement if Licensee breaches any term or condition of this Agreement.
 - 25.2. Upon termination, Licensee must cease using the Product Suite and destroy all copies of the Product Suite.





GENERAL

26. This Agreement represents the entire agreement between Licensee and Ability Engineering Ltd regarding the Product and supersedes all prior negotiations, understandings, and agreements between the parties.

Warranties

- 27. Ability Engineering Ltd. warrants that:
 - 27.1. The software product will only work in environments which are described on the website https://www.eateamworks.com/
 - 27.2. The software product will perform substantially in accordance with the accompanying written materials for a period of 12 months from the date of download.
 - 27.3. Ability Engineering Ltd. will make reasonable efforts to solve any problems associated with the software product during this 12-month period, as reported by you via the https://www.eateamworks.com/ website.

Exclusions

- 28. To the maximum extent permitted by law, all liability is excluded for claims, expenses, losses, damages and costs made against or incurred or suffered by you or anyone else directly or indirectly arising out of:
 - 28.1. Use of the software product;
 - 28.2. Inability to use or obtain access to the software product;
 - 28.3. Negligence of Ability Engineering Ltd. or its employees, contractors or agents in connection with the performance of the software product or support services.
 - 28.4. Termination of this agreement by either party for any reason.

Termination

- 29. Without prejudice to any other rights, Ability Engineering Ltd may terminate this agreement and your right to use the software product if you fail to comply with any of its terms.
- 30. Upon termination you shall ensure that all copies of the software product and all of its component parts are destroyed and / or removed from the computer or network on which they have been placed.

Governing law and jurisdiction

- 31. This agreement shall be construed in accordance with the laws of England.
- 32. Any dispute arising out of this agreement, or the purchase or use of the software product may only be determined by a court in England or Wales.
