



Website terms of use – August 2023

These terms of use (together with the documents referred to in it) tells you the terms of use on which you may make use of our website www.eateamworks.com (our site), whether as a guest or a registered user. Use of our site includes accessing, browsing, or registering to use our site.

Please read these terms of use carefully before you start to use our site, as these will apply to your use of our site.

By using our site, you confirm that you accept these terms of use and that you agree to comply with them.

If you do not agree to these terms of use, you must not use our site.

You must read these terms carefully before using our site. They set out legally binding terms and conditions for your use of our site and all services provided by our site.

By using our site in any manner you agree to be bound by these terms.

1. How www.eateamworks.com works

eaTeamWorks includes eaDocX, ea Revision Manager, eaSheets, Model Expert and Portfolio Manager. The eaTeamWorks suite of software products (**Software**) listed on the website are Sparx Systems Enterprise Architect extensions.

Our site allows you to purchase Software from us. If you purchase Software from our site, you will receive a licence key which is a non-exclusive, non-transferable licence to use the Software plus access to download the Software.

2. INFORMATION ABOUT US

3. Membership Eligibility

You must register as a member in order to use any of the features of our site.

8. CHANGES TO OUR SITE

However, please note that any of the content on our site may be out of date at any given time, and we are under no obligation to update it. We do not guarantee that our site, or any content on it, will be free from errors or omissions.

9. ACCESSING OUR SITE

Our site is made available free of charge.

We do not guarantee that our site, or any content on it, will always be available or be uninterrupted. Access to our site is permitted on a temporary basis. - (i) Promote any illegal activity.
- (j) Be threatening, abuse or invade another's privacy, or cause annoyance, inconvenience or needless anxiety.
- (k) Be likely to harass, upset, embarrass, alarm or annoy any other person.
- (I) Be used to impersonate any person, or to misrepresent your identity or affiliation with any person.
- (m) Give the impression that they emanate from us, if this is not the case.
- (n) Advocate, promote or assist any unlawful act such as (by way of example only) copyright infringement or computer misuse.

You warrant that any such contribution does comply with those standards, and you will be liable to us and indemnify us for any breach of that warranty. If you are a consumer user, this means you will be responsible for any loss or damage we suffer as a result of your breach of warranty.

Any content you upload to our site will be considered non-confidential and non-proprietary, and we have the right to use, copy, distribute and disclose to third parties any such content for any purpose.
